Innovation Fund to support separated families

The Government's Department for Work and Pensions has launched a new Innovation Fund to provide £14 million across Great Britain to support separated families and help them collaborate in the best interests of their children. The programme is being handled through a tender bidding process over two rounds. Contracts can last up to two years and be worth a maximum of £1.5 million. Applications are welcome from the voluntary, public and private sectors, with organisations operating alone or in partnership. Particular interest will be shown in applications from the voluntary sector or which involve voluntary organisations as partners. Applicants can be working in England, Scotland or Wales.

The contract bidding process for the Innovation Fund to support separated families is being managed through the Bravo Solutions procurement website. Object of the contract

Review of the means of accreditation and regulation of the Welsh/English translation profession

Tenders are invited to undertake a review of the accreditation and regulation structures of the Welsh/English translation profession in order to determine the appropriate accreditation and regulation structures to ensure the quality of the work of professional translators so that they support the activities of organisations that are subject to the Welsh Language Measure (Wales) 2012. Further information can be found in the attached brief.

Instructions to suppliers

1. The review will consider the current accreditation and regulation structures of the translation and interpretation profession in Wales, and will specifically scrutinise the work of Cymdeithas Cyfieithwyr Cymru (The Association of Welsh Translators and Interpreters) and the funds allocated to it.
2. In light of the publication of the Welsh Language Measure (Wales) 2012 and the establishment of the Welsh Language Commissioner and the prospective Welsh Language Standards, the review must consider whether the current accreditation and

regulation structures meet the needs made of the profession. Also, the most appropriate structures in the context of the powers of the Welsh Language Commissioner should be considered. The review must also consider the regulatory structures of other professions and the work of other commissioners.

3. The review will recommend which structures are appropriate for the regulation and accreditation of the translation and interpretation profession. The review will therefore aid the Welsh Language Commissioner to determine the best approach to supporting and developing the translation and interpretation industry. It may also help other stakeholders to determine their activities in this field.
4. Tenderers must consider the criteria set out in the specification when submitting their tenders.

Renew Wales will help 200 communities across Wales take action and respond to climate change through advice, training and mentoring support

Funding has been awarded through Sustainable Steps - a non-Lottery funding programme which is being delivered through the BIG Fund and is funded by money that has been dormant in bank and building society accounts across the UK for 15 years or more. The Development Trusts Association Wales (DTA Wales) in partnership with the Centre for Alternative Technology (CAT), Arts Factory and a consortium of climate change practitioners across Wales have led the Renew Wales bid. The programme will focus on areas of fuel poverty, and people and communities of interest not previously involved in climate change activity.

Single body gains legal status

A single body to maintain, enhance and manage the sustainable use of Wales' natural resources now has legal status following a debate in the National Assembly. Environment Minister, John Griffiths put forward an order to establish the single body which will replace the Environment Agency Wales, the Countryside Council for Wales and the Forestry Commission for Wales. The order will give the single body the powers to undertake necessary preparatory work so that it will be fully functional when it formally comes into being on 1 April 2013.

UK News

Defra is developing a new set of sustainable development indicators to meet the Government's commitments to transparency and sustainable development, and is carrying out an informal consultation for 12 weeks from 24 July 2012. The indicators are intended to provide an overview of national progress on key issues that are important economically, socially and environmentally in the long term. Giving local communities a stake in renewable energy projects would help overcome public distrust, a parliamentary committee has concluded. The House of Commons science and technology committee says that giving communities more ownership of local energy infrastructure by offering shares in projects 'could be conducive to building trust and acceptance'. Government confirms new feed-in tariff rates

Small wind turbines see support cut, but hydro and micro CHP set to benefit from new feed-in tariff levels. The government has revealed new support levels for small scale wind, hydroelectric, anaerobic digestion, and micro combined heat and [power](#) (CHP) systems under the feed-in tariff incentive scheme.

The [new rates paid](#) for renewable electricity generated by small scale systems, which were outlined in a response to a consultation earlier this year, will affect tariffs for all newly eligible FITs technologies from 1 December 2012 onwards.

The surge in solar, biomass and offshore wind installations were the main drivers behind a 33 per cent increase in green electricity production last year, according to new government figures that also show the UK imported more electricity than it exported for the first time since 1974.

[Renewable Heat Premium Payment - Phase 2](#)

The £8 million Renewable Heat Premium Payment (RHPP) Community Scheme has been launched by DECC. It will support communities to deliver clusters of domestic renewable heating systems such as air and ground source heat pumps, solar hot water panels and biomass systems. Applications opened 24 July and will run until 7 September. The RHPP community scheme aims to provide communities with the opportunity to cost-effectively organise local buying groups for renewable heating systems, potentially accessing bulk discounts and facilitating easier deployment for installers. The scheme is targeted at off gas areas. The Renew Wales programme, funded by BIG, is able to provide some free mentoring support to groups in Wales who wish to apply - please contact Robert Proctor, Project Director on robertproctor@renewwales.org.uk.

[Arbed - £45 million available for energy efficiency projects](#)

The Welsh Government has launched a new phase of its Arbed investment scheme with an additional £45 million, setting out how Welsh businesses can benefit. The scheme is designed to support home energy efficiency and renewable energy retrofit projects for low income, fuel-poor households in deprived communities in Wales. In addition to reducing

the carbon footprint and delivering economic, environmental and standard of living benefits to disadvantaged communities in Wales, the programme will generate jobs, attract investment and stimulate growth in Welsh energy efficiency and renewable energy businesses.

The call for expressions of interest to the 2013 Ashden Awards has now opened. The aim of the Awards is to promote the widespread use of local, sustainable energy because of the environmental, social and economic benefits which it can provide. The 2013 Awards are broken down into two areas: International Awards and UK Awards. The International Awards offer a Gold Award of £40,000 and four Awards of £20,000; and the UK Awards offer a Gold Award of £20,000 and three individual prizes of £10,000. The deadline for expressions of interest to the UK Awards is 30 October 2012.

[Eurostar Ashden Award for Sustainable Travel - applications for 2013 open](#)

Eurostar, the high-speed passenger rail service, is funding the second round of the Eurostar Ashden Award for Sustainable Travel, a programme designed to showcase local, sustainable travel initiatives in three European countries. The programme will promote sustainable travel initiatives in the UK, France and Belgium where Eurostar operates. It will recognise projects that are innovative, clear, measurable and proven. The award will include a prize fund worth £30,000 and a host of benefits aimed at raising awareness of the winning programme. The deadline for receipt of applications by expressions of interest is 30 October 2012.

[LIFE+ 2012 Call for Proposals Launched](#)

The LIFE+ 2012 Call for Proposals has now been published. The following LIFE+ themes are covered by this call:

- LIFE+ Nature and Biodiversity
- LIFE+ Environment Policy and Governance
- LIFE+ Information and Communication

The total budget available for this call is €276.7 million, of which €21,648,405 has been allocated to the UK. At least 50 per cent of the available funding will be allocated to support the conservation of nature and biodiversity. A maximum of 50 per cent of eligible costs is available for projects, or exceptionally up to 75 per cent for proposals which target priority habitats/species of the Birds and Habitats Directives.

The Commission has introduced an eProposal tool which must be used to submit proposals in 2012. Project proposals should be validated and submitted to the national authority, via the new eProposal tool, by 26 September 2012.

[Inquiry into the implementation of the NSF for diabetes in Wales and its future direction](#)

The National Assembly for Wales' Health and Social Care Committee is undertaking an inquiry into the implementation of the national service framework for diabetes in Wales and its future direction. The terms of reference of the inquiry are: to examine the progress made on implementing the national service framework for diabetes in Wales across the local health boards and its adequacy and effectiveness in preventing and treating diabetes in Wales. The deadline date for responses is **21 September 2012**.

[Minority Ethnic Achievement Grant \(MEAG\) Review consultation](#)

A full review has been undertaken of the MEAG in line with standard grant management procedures. The review considered the effectiveness and impact of the MEAG to date and made a number of recommendations for the future allocation and distribution of the funding. The aim of the MEAG is to raise the achievement of eligible children and young people from minority ethnic backgrounds in Wales including: asylum seekers; refugees; the children of migrant workers, and European Roma children. This consultation exercise affords an opportunity to comment on the recommendations and to suggest how best to configure the grant to ensure that it is fair and results in the best possible learner outcomes.
